21/32.1 All were present.

Declarations of conflicts of interest

21/33.1 None were declared.

21/34

Purpose of the Meeting

21/34.1 It was noted that the meeting was an additional meeting, which had been arranged at short notice to enable three urgent items to be dealt with, without the need for protracted email exchanges. All Directors were present and an agenda, and supporting papers, had been circulated the previous day.

21/35

Membership Renewals

21/35.1 JW had circulated an email sent to all regional chairs by the SE CEO, regarding membership renewals, together with the email exchange between JW and JN that followed this.

21/35.2 It was noted that SE was seeking the Board's agreement to the following course of action:
1. On Wednesday 3rd March Swim England membership team produce the following lists for each region:

Clubs which have not paid

Clubs which have paid

Clubs which have asked for an extension to 31st March and have been granted this extension.

Clubs which have not completed stronger affiliation

2. Swim England to advise clubs (on behalf of the Regions) who have not paid they will be given an extension to 31st March at the latest on the proviso they confirm they will meet the new deadline.

3. Swim England to communicate with clubs regarding the need for affiliation especially as land training and open water swimming is imminent and we have a date for pools to open. If you would also like to communicate with your clubs or would prefer to do so, in place of us, please let me know with your confirmation email.

4. Regions to be advised of clubs who have not paid by 31st March straight after Easter. Clubs to

be suspended and the fine as set out above applied to those who then renew.

5. Clubs which have not complied with Stronger Affiliation will be processed as previously agreed.

- 21/35.3 JW had raised concerns that the proposed course of action was incompatible with a possible change to the SE East Region Regulations, in that there had been no change to Swim England Regulations relating to the deadline of 28th February.
- 21/35.4 In the discussion that followed it was noted that the SE Members Forum had been consulted on a different proposal, and this is what had been agreed by a majority.
- 21/35.5 After full discussion it was agreed that the Board should not agree to this proposal, but revisit the options after receipt of a list on 3rd March. At that stage, the Directors would also consider the implications of taking a different course of action to other regions.
- 21/35.6 JW would convey this decision to Jane Nickerson, SE CEO. **(Action JW)**
