Hints and Tips For Clubs This Month

• Risk Assessments- These are essential for every club to have in place for all events including training, competition, development



activities, trips, fundraising activities, and even online activity! Whilst Swim England provides templates to use, it is for the club to consider its contents, and to make sure all those it impacts are aware, including the coaching team. If ever a claim were to be made, the risk assessment would be part of the evidence required by the insurance firm to show the club considerations to mitigate risk. They need to be updated every 12 months or following an incident.

• Data cleanse- Now is a great time of year to have a clear out and make sure that any old data is suitably destroyed. As a rule, records that have no significant operational, informational or evidential value should be destroyed after its use. Don't forget it is preferable that no data, such as images, registers, or forms, are stored on personal devices.
