	23/07.2	FINA Rules Update 2023		

On the 12 December 2022 in Melbourne; FINA, the Fédération Internationale de Natation, became World Aquatics following a vote at an Extraordinary Congress on the eve of the World Swimming Championships (25m) 2022.

At the time of the meeting British Swimming had not published the Rules update 2023-25 to be delivered to all officials in GB. Swim England. The SE SLG issued the following statement by email on 3 January 2023: -

"World Aquatics (FINA) is currently reviewing its technical rules in all disciplines. In respect of swimming, the revised rules, covering the 2023-25 period, were published on 3 January 2023. The British Swimming Swimming Officials Group will shortly circulate details of the new rules, create training materials and determine a suitable date for their implementation.

The new rules should NOT therefore be applied at swimming competitions held in England until the implementation date is determined.

County Age Group Championships should therefore be judged in their entirety under prevailing Swim England Laws, Regulations and Technical Rules of Swimming, WITHOUT reference to revised 2023-25 FINA Technical Rules."

The quote from SE, 10 March 2023 will be the intended implementation, date for the start of the 'National' qualifying window.

I will be updating the meeting after my meeting for the SE SOG tomorrow.

23/08 British Swimming/Swim England updates

23/08.1 SE Guidance on Water Depths – Diving into Swimming Pools and Competitive Starts

On 8 December 22, Swim England issued guidance on diving into swimming pools. Following a health and safety review, the international governing body's guidance states the minimum depth for racing entries should be 1.35m. From 1 September 2023, all Swim England affiliated clubs will be required to ensure that all starts and changes during relay races are into 1.35m of water.
