23/23.1 British Swimming Referee Course Leader Training (23/08.2)

DM updated the meeting that he had asked for the training to be on the SE SOG agenda on 2 May 23, as there had been no further movement. Disappointingly, this subject, together with other items put forward by attendees, was not an agenda item but a written reply to this and other agenda items submitted by attendees.

The written reply received was as follows:

Update on BS Referee Course Leader training

Will SE do one

Those individuals previously identified by yourselves will be contacted to see if they are still interested. If they respond positively, they will be given access to the resources and added to the list of trainers. As they are your nominations, the onus is on you to assess their continued suitability going forward.

At the date of the meeting Darren Peck, Henry Watkinson, Jane Howell, Louise Mackie had not received information from British Swimming/Swim England. DM to continue to pursue the issue.

23/23.2 BS Para -Swimming CPD for Technical Officials

DM reported that the CPD has been updated and now can be delivered virtually online instead of face to face only. SE are running 4 CPD's in June 23, which have been advertised nationally. DM delivered the first national online CPD on 12 June, which had 75 attendees. DM planned to change the CPD within the region on 17/09/23 to a virtual presentation with a new date, which will be 23 August 23 @ 7pm.

23/23.3 Licensed Meets – Offering of Expenses

DM reported that the last SE SOG, the subject of offering of expenses to technical officials attending licensed meets was discussed. In some regions there had been issues with Promoters not offering expenses or paying very low mileage rates etc to officials, who had not been informed prior to attending the galas.

An agreed wording was agreed and forwarded to the SE SMG for the National Licensing Group to consider. They have accepted the proposal.



The agreed wording:

"All Swimming Officials shall be offered expenses. The Promoters Expense Policy, and current expense rates, shall be included with any License application and made available to Swimming Officials before appointment"

23/24 **Referee Training and Examinations**

23/24.1 The May 23 examination resit results have been announced only to the candidates and course leaders. DM still has not been formally notified of the November 22 results.

> DM had asked the question via the SE SOG, if BS was requiring the November 23 examination be held centrally within each region. Again, this was not an agenda item but a written reply to the meeting.

Q- In November 23, is it a requirement for a central location, I have possibly 10 candidates, is BS paying the room hire.

R-There is no requirement for it to be a centralised venue this year. British Swimming have always paid the costs of the exam, when asked to and when considered reasonable. However, we would remind people that there is no requirement for

invigilators to have any connection to swimming, so excessive travel claims are not expected.

CG and DM spoke regarding the positive feedback from the Race Results course CG ran earlier this year. There is a Revision course planned for 14 October 2023.

Moving forward, they plan to run a series of training sessions face to face if there is sufficient demand in 2024.

The meeting supported the proposal, CG and DM to plan for the 2024 budget. **Action: CG/DM**

A discussion took place by County coordinators as to what was going on withing their own Counties and future planning.

Problems /Issues encountered etc:

Bedfordshire- not attended

Cambridgeshire- no executive committee, which brings its problems

Essex- Jane will do a WA update on the 4 July 2023, shortage of Referees for galashowever, recently 6 galas on one weekend, and not enough volunteers. Promoters have been reminded to get the strategic people in place.

Hertfordshire- similar issues, gala cancelled because of lack of referees & officials. Officials not treated with respect.

Norfolk- struggling in recruitment in clubs for JL1 (JL1 8 signed up this year, 22 x JL2) Suggested that a TK course was a quick win (online course)

Suffolk – Podge had previously advised me of a question about further WA updates-are we going to run anymore?

Judge level 2/judge level 2S course applications - DM agreed to send to the candidate, when he acknowledges their application, a copy of the Swim England training requirements at licensed meets.

Training Workbooks - Essex, Norfolk and Hertfordshire post new candidates a printed copy for their training.

Judge level 1 poolside experience – DM reminded everyone that county coordinators must also check that the candidate has attended level 1 or 2 galas either during their mentoring as a judge level 1 or post qualification before they can move onto judge level 2 training.
