24/07

24/08.1 British Swimming Referee Course Leader Training

DM updated the meeting that CG attended the SE SOG Meeting on 13/11/23 as he was on travelling to a WPS Competition in Chile. CG had produced a written report which was circulated to SOLG members following the meeting.

No courses for referee trainers. Course not deemed suitable to be delivered by zoom. Regional coordinators to select candidates and send name, membership number and email address to Helen. They will be given access to the online box files and in addition have access to some of the documentation used in the previous course for course leaders, particularly regarding the ways that different people learn. 24/08.2 BS Official's Licensing Form

A new License Renewal application form was discussed, and it was agreed that it was easier to use. CG asked that the reference to FINA in M6 be changed to WA.

24/08.3 IOS Courses

24/08.4 List of Licensed Officials

The faults with the September list of SE licensed officials has now been fixed. Updated SE lists were received by DM on 15 January 24 and have been circulated to all County Coordinators.

24/08.5 World Aquatics Rules Updates

World Aquatics updates were discussed, Mark Davies (SESOG Chair) advised that 4115 people out of a potential 5000 had completed an update session. There are currently no plans to make this an online version as it was felt people would just skip through it without any interaction, this will be reviewed early next year.

East Region have presented 45 CPD's within the Region with 578 Technical Officials attending.

24/08.6 Judge Level 2/ 2S Workbooks

The old versions of workbooks are now out of stock, newly updated versions in A5 format are being designed and printed. These books will be of a similar format to the existing JL1 workbooks.

24/08.7 Contemporary Issues

The requirement to have successfully completed a recent Contemporary Issues CPD before relicensing has been removed for licensed officials. The requirement will stay for JL1 trainees to enable them to be licensed upon completing their training and becoming a qualified JL1.

24/09 Referee Training and Examinations

24/09.1 Eight Candidates took the BS Referee written examination on 4 November 23, seven who were successful in passing the examination. DM has written to the Candidates congratulating them on their success.

24/09.3 BS Referee Course Leader Training (24/08.1)

DM reported to the meeting that it was disappointing that BS/SE have decided not to provide any training for new Referee Course Leaders, after he had been pressing for a new course since 2019.

DM with the assistance of CG and GM put together a training package for new Course Leaders. This was to ensure that both the course leader and the candidates are catered for their training needs.

On the 5 January 2024 an online training session took place, all existing and new Referee Course Leaders were invited. DM/CG/GM presented the information to everyone who attended.

The meeting requested that Helen Akers (HA) update the new course leaders BS records that they are now Referee Course leaders and allow them access to the SE Referee Box files.

Hertfordshire

First county champs last week, further to come, no issues. The operator is not happy that they don't have spectators. Various reasons. Stands used for swimmers as not enough room at Borehamwood.

Norfolk

Weekend of distance at counties (jointly with Suffolk), plenty of officials, more JL2's in training than JL1's, plenty of referees

Suffolk

Weekend of distance at counties (jointly with Norfolk), plenty of officials, not many referees
