25/045.1 Apologies were received from Lottie Thompson.

25/051.1 A presentation was shared, showing a work-in-progress strategy document for the purpose of feedback from the Directors. IM asked if permission would be needed to use images in the document. SMu stated 25/051.2 that Swim England had not gained permission from individuals to use their image. 25/051.3 SMu has written an introduction to the East Region Strategy, but, as this is a message from all the Directors, input would be welcomed. Some of the Goals have been updated since the last presentation, to better reflect 25/051.4 what is achievable within the Region. Each Goal now has a short paragraph explaining how it will be achieved. Feedback on the wording was requested. 25/051.5 SMu presented what the Strategy group believed to be the five Priorities and asked for feedback on this. IM praised the group for their work on the document 25/051.6 Action - work-in-progress strategy document to be shared with all Directors for feedback Risk Register 25/052.1 A new item has been added to the Risk Register following a suggestion from the Audit Risk & Probity Committee. 3.3 Difficulties recruiting Directors and Leadership Group Managers. This is currently Low risk as four new Directors have recently been recruited, all the 25/052. Leadership Groups have a Manager, and there are nominations for all the posts for election at the Annual General Meeting. Regional Manager Report 25/053.1 JSa presented his report. 25/053.2 He informed the Board that Swim England has recently appointed a Technical Facilities Officer, who is currently working on a number of projects in East Region. The three main projects are at Stevenage Swimming Centre, Kings Lynn and Cambridge University. 25/053.3 SMu asked why Stevenage were looking at a 10-lane pool, 1.8m deep, when this would exclude Artistic Swimming at that pool, rather than a deeper 8-lane pool. It was explained that the pool operator and Council wanted a larger pool area to maximise their Learn-to-Swim provision. Currently the Artistic Swimming club only train at the pool for one hour per week, but, as the Region holds the regional Artistic Swimming competitions at the pool four times a year, another venue would have to be found for these.
