## 25/074 Apologies and introductions

25/074.1 Apologies were received from James Salmon (JSa) Regional Manager.

#### 25/075 Declarations of conflict of interest

25/075.1 There were no declarations of conflict of interest.

### 25/076 Welfare Officer's report

25/076.1 FV explained various points in the Welfare Officer's report.

25/076.2 FV screen-shared a document explaining the difference between a level one safeguarding case and a level two. The document had been produced by Kevin Suckling, head of Swim England Safeguarding.

FV explained that a level one low level safeguarding welfare concern is one which can be resolved locally. They are generally low level Wavepower breaches /emotional harm, and are non-complex issues suitable for local resolution. They are generally managed by clubs, sometimes supported by the County Welfare Officer, the Regional Welfare Officer or the National Welfare Officer.

A level two safeguarding case is one where there is a potential risk for harm, and this would be managed by Swim England's Safeguarding team. It would be sent to sports resolution for an independent investigation.

25/076.3 FV clarified the acronym LADO as a local authority, designated officer. Every authority has a LADO.



25/076.4 KB asked if the spike under the Policy/Procedure/Governance was a reflection of the recording of every sort of communication like finding sections in Wavepower. He also asked whether the information is being shared with other Regions to see if their situation is similar.

FV stated that explanations of Wavepower are often asked for, and that she would like one of the FAQs on the website to cover Wavepower.

## 25/076.5 Independent advisor

FV presented her proposal for an independent advisor and explained why it would be beneficial.

25/076.6 TB asked if Swim England supports this.

FV was not sure if Swim England supports the Regions in having independent advisors, but Swim England do have their own independent advisors.

25/076.7 SMa asked FV why she cannot use the National Welfare Officer at Swim England to discuss ideas and to get advice and help.

FV explained that she does approach the Welfare Officer at Swim England to seek advice and help, but feels that there is a lack of interest in the development of the Regional Welfare plan.

25/076.8 SMa also asked FV about the possibility of working through the National Welfare Officer to seek advice from their independent advisors.

FV stated that she will check on this.

25/076.9 SMu thanked FV for joining the meeting. FV left the meeting.

SMu has inspected the new medals and there does not appear to be any significant quality issue. The quality of the medals will be reviewed at the next event.

25/080.1 The monthly budget reports had been circulated. No issues were identified.

25/081 Leadership Group minutes

25/081.1 The minutes for Open Water meeting had been circulated. No issues were identified.

25/082 East Region Strategy

25/082.1 The Strategy is nearing publication.

The Audit, Risk & Probity (ARP) committee have seen the document and are happy with the content and process.

- 25/082.2 SMu reported that the document has also been presented to the County Forum so that the county chairmen and secretaries have an understanding of what the Region is proposing. It was well received, and it was requested that SMu has a meeting with club chairmen in the Region to explain the Strategy in detail.
- 25/082.3 Ali Wyke and Claire Coleman, Swim England, have both reviewed the Strategy and given comments back. They are happy with the content and the alignment with the One Swim England Strategy.
- 25/082.4 SMu reported that the Strategy will go to Swim England marketing for consistent branding ec. It should meet the target of publication by the end of June.
- 25/082.5 HS asked about the scorecards.



SMu reported that the action list and scorecards may take another four to six weeks to finalize, but that will not affect the issuing of the Strategy.

## 25/084.2 Swimming Long-Course survey results

SMu reported that a survey had been sent out following the Regional Long-Course meets to request feedback from volunteers, both non-technical and technical. 31 responses of the 141 were anonymous.

25/084.3 The results of the survey had been circulated, and comments/feedback had been given.

Following the comments/feedback, for further event surveys a draft copy will be sent to the discipline manager for review and alterations before being sent out to the volunteers.

### 25/084.4 County Governance update

Four of the six counties have completed County Governance. Cambridgeshire and Essex are still to complete.

### 25/084.5 **G9 update**

The terms of reference for the group have now been agreed, as well as an engagement process for any project work. The plan is to have two face-to-face days per year and two online days per year, as well as a monthly online meeting.

25/086.1 SMu reported that he had attended his first face-to-face Regional Chairs' meeting in London. He gave a review of the agenda and what was discussed. SMu said that it gave him the opportunity to meet the other Regional Chairs and understand some of the issues they are dealing with within their Regions.
