25/23		Welcome and apologies
	25/23.1	AD welcomed everyone to the meeting.
	25/23.2	Apologies received from Jayne Jarvis (JJ), Potters Bar, and Emily Gower (EG), Norwich.
	25/23.3	EC left the meeting at 10.40am and MH attended for the rest of the meeting on behalf of EC.
25/24		Declarations of conflict of interest
	25/24.1	There were no declarations of conflict of interest.
25/25		Previous minutes
	25/25.1	The minutes from the previous meeting had been circulated.
	25/25.2	25/14.2 The date of the competition is 18 th October. The minutes will be amended.

25/25.3 The minutes were agreed with the above change. 25/26 Plan and Budget 25/26.1 AD reported that the budget is on target. The budget and plan will be reviewed at the next meeting, with a look at the budget for 2026. 25/26.2 AD reported that a good number of swimmers are attending the Regional Games training. This is good in respect of the development within the discipline. 25/27 **Grading days 2025** 25/27.1 AD advised that the next grading day is a Swim England Hertfordshire county grading day which TB is organising. TB reported that the planning is going well. The closing date for entries is 20th 25/27.1.1 September 2025. 25/27.2 AD reported that the next regional grading day is being held on 9th November 2025 at Hemel Hempstead. Three hours of pool time is available. 25/27.2.1 A discussion took place around the content of this day – figures or routine grades. 25/27.2.2 There was discussion about when retakes could be arranged for any failures on 9th November. There is a possibility of having a grading day in December, and there will definitely be one in January. 25/27.3 EC asked if the dates had been released for next year's competitions. AD confirmed that the National Age-Groups (NAGs) are on 14th and 15th March 2026, and the Championships are on 25th and 26th April. Combo and Masters are on 4th and 5th July. 25/28 **Competitions for 2025** 25/28.1 EC asked if coach cards are required for the October competition. AD confirmed that are needed for the solos and duets. 25/28.2 EC also asked if the swimmers need to include a connection within a hybrid in duets. 25/28.2.1 A discussion took place around hybrids and connections, and KB suggested double-checking the rules as if it is just a connection then it is on the surface, but if it is a hybrid connection then it will be a connection upside down. 25/28.2.2 AD advised that the rules for the October competition do not state that there has to be a connection within a hybrid.



	25/28.2.3	AD advised that if a swimmer does not have a grade, they can enter as a grade 1. They can also swim up a grade if they feel ready.
	25/28.3	AD reported that the 2026 competitions will be worked around the National competition dates. Dates will be looked at after the October competition.

	25/31.1	LN asked if there is going to be a Swim England Artistic Swimming Conference this year. AD reported that she has not heard/seen anything about a conference this year.
